ORDINANCE NO. 736

AN ORDINANCE ESTABLISHING NEW ELECTRICAL RATES FOR THE CITY OF WASHINGTON, KANSAS.

WHEREAS, the Governing Body of the City of Washington, Kansas, has determined that it is necessary to change the rates charged for the purchase of electricity from the City;

NOW THEREFORE, Be It Ordained By The Governing Body Of The City Of Washington, Kansas:

SECTION 1. The current provisions of Chapter XVII, Article 1, Section 17-101b of the Code of the City of Washington, Kansas, 1985, is hereby deleted and repealed.

SECTION 2. The following provisions are hereby adopted as Section 17-101b Article 1 of Chapter XVII of the Code of the City of Washington, Kansas, 1985:

17-101b. MONTHLY RATE.

	June through September	October through May
For the 1 st 500 KWH	0.0976 per KWH	0.0976 per KWH
For all KWH over 500	0.1122 per KWH	0.0885 per KWH

SECTION 3. The current provisions of Chapter XVII, Article 1, Section 17-102b of the Code of the City of Washington, Kansas, 1985, is hereby deleted and repealed.

SECTION 4. The following provisions are hereby adopted as Section 17-102b, Article 1 of Chapter XVII of the Code of the City of Washington, Kansas, 1985:

17-102b. MONTHLY RATE

	June through September	October through May
For the 1 st 2500 KWH	0.1036 per KWH	0.1036 per KWH
Next 7500 KWH	0.1012 per KWH	0.1002 per KWH
For all KWH over 10000	0.0880 per KWH	0.0859 per KWH

SECTION 5. The current provisions of Chapter XVII, Article 1, Section 17-103A(d) of the Code of the City of Washington, Kansas, 1985, is hereby deleted and repealed.

SECTION 6. The following provisions are hereby adopted as Section 17-103A(d), Article 1 of Chapter XVII of the Code of the City of Washington, Kansas, 1985:

17-103A(d). NET MONTHLY RATE

Demand Charge

\$6.00 per kw of demand

Energy Charge

0.0417 per kWh used per month

Minimum Charge

\$50.00 per month which charge shall be in addition to the charge for any electricity used.

SECTION 7. This Ordinance shall take affect and shall be in full force and effect after its publication in the Washington County News, the official city newspaper.
