## 10. City Administrator Report.

- a) Larry A. Davison Estate. Staff received notice from City Attorney Elizabeth Hiltgen that the Estate of Larry A. Davison had named the City as a beneficiary for 10% of his estate to be used specifically for the City's park.
- b) Rock Crushing. Vogts Crushing, LLC, began crushing rock in mid-December.
- c) Water Rate Review. Staff will be reviewing expense and revenue for the past 12 months, along with projected debt service payments to determine if a water rate increase will be warranted.

### 11. City Clerk's Report.

- a) USDA Loan. Sarah Hines, USDA, emailed City Clerk Denise Powell about closing out the RD loan/grant and paying off the temporary financing by the end of March to take advantage of the low interest rates which is currently 1.75%. This would save the City considerably on interest during the 40-year term of the loan. The interest rate at the time of obligation of the temporary financing was 3.125%.
- b) Damage Claim. December 8, 2020, Blanche Graham turned in a Damage Claim for sewer damage to her basement from an incident on November 14, 2020. She stated she had not filed the claim against her personal insurance as she felt it was due to the City issue. Staff submitted the claim to City's insurance provider, The Dragastin Agency, on 12-8-20. Staff received a bill from EMC Insurance December 21, 2020, requesting payment for the \$1,000 deductible. A copy of the loss summary payout is enclosed for review. Chalfant stated Graham will install a backflow preventer.
- c) Damage Claim. January 4, 2021, Cynthia Zabokrtsky turned in a Damage Claim for a bill received from Pure Energy stemming from a sewer tap that was not cut open when the company lined the sewer this summer as it was not properly designated on the project plans. Once the problem was discovered City Administrator Carl Chalfant notified Midlands Contracting Inc. who sent someone to open the tap. Consensus of the Council was to pay Pure Energy and give the city's insurance provider a heads up.

## d) Reports.

The November 2020 financials for the Washington County Senior Citizens Meal Sites and December Fire Department minutes were given to the Council for review.
