5. Insurance Dividend.

Justin Dragastin, The Dragastin Agency, informed the Council the City received \$13,793.30 through this year's KMU Safety Dividend program. The dividend is calculated on the group's overall loss experience and is a percentage of the premiums paid. It's comprehensive safety and loss control program helps participants minimize risks and potentially reduce insurance cost.

7. Phone System bid.

Motion to approve the bid of Networks Plus for phones/phone system at \$25 per line with voicemail, \$20 without voice mail and \$10 for fax line for 36 months with City Administrator Carl Chalfant waiving the bid deadline per the purchasing policy as referenced under late bids by Pinnick seconded by Crome.
