All parents/guardians are asked to read the following rules and discuss them with your children/family members. The following rules are posted on the fence at the pool and apply to ALL pool users:

- 1. No running in pool area.
- 2. No obscene language.
- 3. No dunking or rough play.
- 4. Go straight off the board and swim to the side.
- 5. All candy and pop must stay in designated area.
- 6. No floating objects, mask, or games allowed in the 12-foot area.
- 7. No alcohol or tobacco products allowed in pool area.
- 8. Swimsuits and trunks required.

The following rules are not posted but apply to ALL pool users:

- 9. No one is allowed in the pool unless a lifeguard is on the lifeguard stand.
- 10. No outside food or drink allowed.
- 11. ALL food and beverages MUST be kept inside the designated area. Absolutely NO food or beverages will be allowed outside of this area.
- 12. No chewing gum in the pool.
- 13. Patrons will be required to sign in each time they visit the pool.
- 14. Children 8 years old or younger must be accompanied by an escort (14 years of age or older) while at the pool. Children 6 years old or younger must have an escort in the water with the child. No exceptions.
- 15. Snug fitting swim diapers are required for all children who normally wear diapers. Accidents in the diaper still need to be reported to staff members.
- 16. The City of Washington is not responsible for lost or stolen items. Lockers are available for use in the restrooms. Locks are available at the front desk and may be checked out at no cost to the patron. Locks and/or keys not returned will be charged to the patron at \$5 per lock and/or key.
- 17. All patrons must wear swimsuits or swim trunks. Denim, cutoff shorts, thongs, or otherwise inappropriate swimwear as determined by management are prohibited.
- 18. If a lifeguard has concerns about your child's swimming ability, the guard may require your child to show that they can swim a lap of the width of the pool before being allowed in the deep end. This is a SAFETY measure and is at the lifeguard's discretion.
- 19. Lifeguards are in place to ensure the safety of all pool users. The lifeguard WILL NOT, SHALL NOT, CANNOT be considered a supervisor or babysitter of anyone's children.
- 20. If a patron needs to visit with a lifeguard, kindly wait until they are off their post, or seek out a guard who is not at a post poolside. Do not divert the guard's attention away from the pool.
- 21. The telephone at the pool is for emergency purposes. Use of the phone is permitted provided the call is kept to less than two minutes. The lifeguards are not responsible for answering the phone. Phone use is a privilege and will be denied to anyone abusing it.
- 22. Individuals causing disruptive behavior will be subject to discipline procedures, such as warnings, time out, or expulsion from the facility.
- 23. Management reserves the right to disallow any activity deemed to be unsafe, unsanitary, or inappropriate.
