### **INVITATION TO BID**

The City of Washington, Kansas, is inviting bids for the surface preparation and painting of the City of Washington Swimming Pool.

Proposals will be received at the City Clerk's Office, P.O. Box 296, 301 C Street, Washington, Kansas 66968, until 1:00 p.m. on Monday, November 25, 2024. All bids should be clearly marked "Swimming Pool Bid". Faxed or electronic bids will be accepted. Bids may be faxed to 785-325-2678 or emailed to wsems@washingtonks.net.

All submitted bids shall be honored for 60 days after the bid opening.

Bids will be opened at 1:00 p.m. on Monday, November 25, 2024, in the City of Washington Council Chambers. Bids will be reviewed and a recommendation made to each City Council for consideration on Monday, December 2, 2024. Bidders will be notified the next business day after the council meeting.

The Council reserves the right to reject any or all bids with or without cause and to waive any irregularities.

#### **BID INSTRUCTIONS**

### **Swimming Pool Painting**

#### **GENERAL**

The City of Washington Swimming Pool has approximately 7,800 square feet of surface area, which requires surface preparation and painting. The pool was constructed in 2009, and has just completed its 15th season of operation. The pool was initially painted with Kelly Olympic epoxy paint, and it was repainted in 2019 with Tnemec's High build epoxy series, and compatible epoxy paint for repainting is required. The surface paint is white, with black lane line markings and red depth marking line. Color scheme shall remain the same as it is currently.

#### **TIMELINE**

Ideally, this project should be completed before the next pool season with enough time to cure prior to Memorial Day, 2025. Bid should include projected start date.

#### **BID SPECIFICATIONS**

Bid should include surface preparation/cleaning, epoxy paint, all materials and supplies, and labor. All-inclusive bids are acceptable.

Surfaces must be prepped according to manufacturer's recommendations, including sand blasting as needed, removal of contaminants, acid washing, and cleaning.

As an alternate, we would like to know if you have the capability to resurface diving boards, and if so, please include a bid for that as well.

#### **BIDDER REQUIREMENTS**

The successful bidder must follow all OSHA regulations while engaged in this project. Bid must include proof of liability insurance and workmen's compensation coverage.

#### **REFERENCES**

Bid should include at least two references for similar projects.

#### **TAXES**

This purchase is tax exempt. Appropriate certification will be supplied to the vendor upon request.
